

# ■ APPLICATION FORM TO THE DATA CONTROLLER

(In accordance with the Law No. 6698 on the Protection of Personal Data)

## 1. General Information

As defined in Article 11 of the Turkish Personal Data Protection Law No. 6698 ("KVKK"), individuals ("Applicants") have the right to request certain actions regarding the processing of their personal data.

This form has been prepared to determine your relationship with **CEVDET ÖZ TURİZM GIDA İNŞAAT TAAHHÜT TAŞIMACILIK TEKSTİL VE TİCARET LİMİTED ŞİRKETİ ("VOX MARIS")**, to identify the personal data processed by VOX MARIS (if any), and to ensure that your requests are responded to accurately and within the legal timeframe.

To protect your personal data and prevent unauthorized disclosures, VOX MARIS may request additional information for identity verification. VOX MARIS is not responsible for inaccurate, outdated, or unauthorized applications.

Pursuant to Article 7 of the Communiqué on the Procedures and Principles of Application to the Data Controller, no fee will be charged for up to 10 pages. If the response exceeds 10 pages, 1 Turkish Lira may be charged for each additional page. If the response is provided on a storage medium (e.g., CD, USB), the cost of the medium will be charged.

## 2. Scope of the Right to Apply under Article 11 of the KVKK

As a data subject, you can request the following:

1. To learn whether your personal data is processed,
2. To request information if your personal data has been processed,
3. To learn the purpose of processing and whether the data is used in accordance with this purpose,
4. To know third parties to whom your data is transferred (domestically or abroad),
5. To request correction if your data is incomplete or incorrect and to request notification to third parties,
6. To request deletion, destruction, or anonymization of personal data if the legal grounds no longer exist,
7. To object to any negative outcome resulting from automatic data processing,
8. To request compensation if you suffer damages due to illegal processing.

## 3. Application Methods

Your application can be submitted in writing and signed, or via other methods accepted by the Turkish Personal Data Protection Board.
