

Cookie Policy

This Cookie Policy has been prepared by **CEVDET ÖZ TURİZM GIDA İNŞAAT TAAHHÜT TAŞIMACILIK TEKSTİL VE TİCARET LİMİTED ŞİRKETİ** to provide information about the cookies and similar technologies placed on your device when you visit our website. This policy explains what types of cookies are used, for what purposes they are collected, how they can be managed, and how you can exercise your rights under the Personal Data Protection Law (KVKK).

Except for strictly necessary cookies, your explicit consent is obtained for the cookies used on our website, and you are provided with the opportunity to change your consent at any time. Through the cookie management panel, users can view the types of cookies used on our website and set their preferences for all cookies other than strictly necessary ones by choosing “on” or “off.” Users can also change their preferences at any time through this panel.

What is a cookie?

A cookie is a type of identification file placed and read by the browser used by the visitor of a website. Cookie files may store various data such as the user's session information, duration of content consumption on a page, and content consumption habits.

Our cookies are used to provide you with a personalized experience during your use of our websites, to improve our services, and to enhance your experience.

Cookies can be categorized under different headings depending on their purposes and uses. Some of these categories are explained below:

Types of cookies

By duration:

Our website uses session cookies and persistent cookies.

- Session cookies are used to maintain session continuity and are deleted when the browser is closed.
- Persistent cookies remain after the browser is closed and are automatically deleted after a set time or date.

First-party and Third-party cookies:

- **First-party cookies** are placed directly by the website the user visits (shown in the browser address bar).
- **Third-party cookies** are set by domains different from the visited domain.

By purpose:

1. Mandatory Cookies:

These cookies are necessary for the website to function correctly and enable core functions. They are also used to provide services you requested (e.g., login, form submission, remembering privacy preferences). Blocking these cookies may affect the functioning of parts of the website.

2. Analytical/Performance Cookies:

These cookies enable statistical analysis of user behavior and help improve the website.

They are used to estimate visitor numbers, measure traffic, identify key search terms, or monitor site navigation. They help measure and optimize website performance.

3. **Functional Cookies:**

These cookies make the website more functional and support personalization (excluding privacy preferences, other preferences are remembered for your next visit).

4. **Advertising/Marketing Cookies:**

These cookies track users' online behavior to determine personal interests and display targeted ads. The goal is to make advertising more efficient and precise. Behavioral online advertising is commonly used.

Processing Personal Data and Legal Grounds

- **Mandatory Cookies:** Data is processed under KVKK Art. 5(2)(c) (necessary for contract performance) or Art. 5(2)(f) (legitimate interest).
- **Analytical/Performance Cookies:** Processed based on your **explicit consent** (KVKK Art. 5(1)).
- **Advertising/Marketing Cookies:** Processed based on your **explicit consent** (KVKK Art. 5(1)).
- **Functional Cookies:** Processed based on your **explicit consent** (KVKK Art. 5(1)).

Services and Cookies Used

- **Google Tag Manager:** Tracks if tags are loaded to analyze website performance.
- **Google Fonts:** Provides high-quality fonts from Google servers, improves load speed, and ensures consistent appearance.
- **Google Static:** Supports static maps and content, stores user preferences.
- **unpkg:** Loads open-source JavaScript and CSS libraries efficiently, supporting interactions and personalization.
- **Google reCAPTCHA:** Security service to prevent spam and bots, verifies if user is human.
- **Google APIs:** Integrates Google services (Maps, Gmail, YouTube, etc.), cookies may be set during use.
